Dear Mr. Hoeme,

On August 28, 2015, the Sedgwick County Sheriff's Office received your request for records under the Kansas Open Records Act ("KORA"). You requested: "an accounting of all money used by the Sedgwick Sheriff's Department, its deputies and investigators during the investigation of Jezebels, its employees and patrons."

Enclosed are two *Requests for Purchase of Supplies/Equipment/Clothing* dated 12/3/2013 and 5/21/2014. The investigations division received a total of \$25,000 for the project. At the conclusion of the project, \$363.00 remained unspent. Names of undercover agents have been redacted from these pages, pursuant to K.S.A. 45-221(a)(10)(C).

To the extent other records exist which meet your request, your request is respectfully denied. The release of such records is not required under KORA, pursuant to K.S.A. 45-221(a)(10)(B), K.S.A. 45-221(a)(10)(C) and K.S.A. 45-221(a)(10)(D). Also, your request is respectfully denied on the basis that records of investigations currently being prosecuted are only to be disclosed in the normal discovery process in compliance with court orders, per K.S.A. 22-3212(e). See K.S.A. 45-221(a)(1).
