### Venue & Parking

- Address: Robert J. Dole Federal Courthouse, 500 State Ave, Kansas City, KS 66101
- Enter via Main entrance on State Ave, south side of building.
- Handicapped parking: adjacent lot to the north (Nebraska Street entrance).
- Public parking: SE corner of 5th Ave and Washington Blvd (across from FBC).
- Free city lot next to the Merc on 5th and Minnesota.
- City parking lots with hourly rates are located on the 500 block of Armstrong Avenue and the 400 block of State Avenue.
- The strip mall lot on the corner of 5th and State Ave., east of the building, is private parking and you may be towed.

### Courthouse Entry & Protocols

- You must show a photo ID and pass through security to enter the courthouse.
- Lawyers, including pro hac vice attorneys, who present photo ID and a current bar registration card from this or any other federal or state court may bring in electronic communication devices (see Local Rule 83.2.4).
- Photography or audio/video recordings of court proceedings is strictly prohibited. The Court may grant permission to bring cameras in for ceremonial proceedings or court events. Contact the local clerk's office for more information.

## Meeting Room & Check-in

The seminar will take place in the **Special Proceedings Courtroom** on the **6th floor**.

Attendees will **check in** at the registration table outside the courtroom and pick up their program booklet. The program will begin promptly at noon. Please arrive in time to be seated before then.

The panelists will entertain questions from in-person and virtual attendees during the last 15 minutes of the program. In-person attendees must submit their questions on slips of paper or notecards to be provided at check-in. A member of event staff will collect these around 12:30.
