### **Tech Prep & Precautions to Ensure a Smooth Experience**

- To ensure you receive this email, add no-reply@zoom.us & CLE@josephhollander.com to your email client's/ firewall's Safe Senders list.
- Make sure you have the latest version/update of your Zoom client installed on your computer at least 15 minutes prior to joining.
- Do not attempt to join the Zoom session sooner than 15 minutes before the start time, or it may force you to reregister! Even then, it may not allow you to join! Join between 11:45am and noon. The host will let you into the session promptly at noon.
- Make sure you are signed into the Zoom account under which you registered lest someone else get credit for your participation.
- Make sure you click the unique join link Zoom assigned and emailed to you at registration. Every registrant has a unique link tied to their registrant record. These links cannot be shared with other attendees. Each attendee must have and use a unique join link to have their attendance validated.

### **Poll Question Instructions**
